EXHIBITOR INFORMATION

Exhibit Booth

10' wide by 8' deep, exhibitor sign, covered table, side rails and backdrop. Exhibitors are welcome to bring signage, backdrops, etc. as long as all items fit within the confines of the booth.

Electrical Hookup

If an electrical outlet is required, the cost is \$75 extra. Outlets must be requested in the online registration form.

WiFi

Exhibit Setup

Exhibitors may setup **AFTER 9:00am on November 10th**. No exhibit will be allowed to assemble prior to this time. All exhibits must be ready by 10:30am.

Shipping Booth Contents

EXHIBITOR INFORMATION *(Continued)*

DIRECTIONS

I-84 East From Waterbury

Take Exit 28. Take right onto Route 322. Go straight, under second underpass take left (at car wash) onto Old Turnpike Road. At the first stop sign, take a right onto Mulberry Street. Aqua Turf Club is located 1/2 mile on the right.

I-84 West From Hartford

Take Exit 29 (left exit). At the end of the exit, there will be a light. Go straight through the light onto Mulberry Street. Go approximately one mile down the road. Aqua Turf Club will be on your right.

From I-91 or the Merritt Parkway

Take Route 691 West toward Waterbury. Take Exit 4 (Southington), then take a right. At the bottom of the hill (McDonald's is on the corner), take a right onto South End Road. Follow until you come to Mulberry Street on the left. The Aqua Turf Club is on Mulberry Street approximately 1/4 mile on the left.
